3. Arrival & Setup

Performer agrees to:

- Arrive at least an hour before the faire opens
- Arrive to the stage/performance space at least 15 minutes prior to scheduled performance
- Provide their own costumes, instruments, props, and equipment unless otherwise agreed
- Conduct themselves in a safe and responsible manner

Organizer agrees to:

- Provide reasonable access to performance space
- Provide agreed-upon staging, sound, or technical support (if applicable)

4. Safety & Liability

Performer agrees to:

- Follow all local, state, and federal laws
- Follow all event safety guidelines
- Carry appropriate insurance if engaging in high-risk performances (e.g., combat, fire, animal acts)

The performer assumes responsibility for their own equipment and personal property. North Inch Renaissance Faire and its committee members are not responsible for lost, stolen, or damaged items.

If applicable, the performer agrees to indemnify and hold harmless the event director from claims arising out of the performer's acts or omissions.

5. Cancellations

If the performer must cancel, they agree to notify the organizer as soon as possible. If the event is canceled due to emergency, or unforeseen circumstances, the organizer shall not be liable for additional compensation unless otherwise agreed in writing.

6. Faire School

All performers are required to attend at least 2 out of 4 of our Faire school sessions. These will include informing and educating cast, crew and actors in faire etiquette, character development, period appropriate speech, as well as serve as a way for performers to demonstrate their skills and/or audition. All performers will be given plenty of notice before each Faire school. The first one is taking place on May 2nd, at 3:00 p.m. in the large Ramada at Rumsey Park in Payson, Arizona 85541.

7. Conduct

Performer agrees to:

- Maintain appropriate behavior toward attendees, staff, and other participants
- Refrain from illegal substances
- Avoid discriminatory, hateful, or excessively explicit content

Failure to comply may result in removal from the event without compensation.

8. Media Release

Performer grants North Inch Renaissance Faire permission to photograph, record, and use images or recordings of performances for promotional purposes, including social media, website, and print advertising.

Combat Performance Risk Acknowledgment & Waiver

This section applies to any Performer participating in staged combat, live steel demonstrations, martial displays, mock battles, weapons demonstrations, or other combat related performances.

By signing this Agreement, the Performer acknowledges and agrees that:

1. Assumption of Risk

The performer understands that combat activities involve inherent risks including, but not limited to: bodily injury, serious injury, permanent disability, disfigurement, death, property damage, and other unforeseen risks. The Performer voluntarily assumes all risks associated with participation in these activities.

2. Training & Competence

The Performer represents that they possess adequate training, skill, and experience necessary to safely conduct their Combat Activities. The performer agrees to use properly maintained equipment and to follow recognized safety standards for staged combat and weapons handling.

3. Safety Compliance

The Performer agrees to:

- Participate in any required safety briefings
- Follow all event safety rules and designated performance boundaries
- Immediately cease performance if directed by event staff due to safety concerns

4. Protective Equipment

The performer agrees to use appropriate protective gear where applicable and acknowledges that failure to do so is at their own risk.

5. Release & Hold Harmless

To the fullest extent permitted by law, the Performer releases and holds harmless the Event Organizer, its owners, volunteers, staff, sponsors, and affiliates from any claims, demands, liabilities, damages, or causes of action arising out of or related to participation in Combat Activities, except in cases of gross negligence or willful misconduct.
